

Gordon Maynard passed away on November 17th at the age of 94.

He was probably the oldest resident of Ash, who was actually born in the village.

Born in a downstairs room at Stone Farm in 1925, Gordon attended Ash school and left at the age of 14 to work on the farm with his father.

In 2013 he wrote a book, detailing one hundred years of history of life on the farm, while the Maynard family have been there (1912 -2012). Many people in the village have a copy or have read it.

Gordon over the years had been an Ash Parish Councillor, Stanchester School Governor and a member of the Gideons. He was a gifted musician and singer and performed for many years with the South Petherton Choral Arts Society.

At one time he knew every villager in Ash.

He was a member of Martock Christian Fellowship all of his life and involved in Christian work, both in this country and abroad.

A large number of people attended his Thanksgiving service, including many from Ash and donations given in Gordon's memory, amounted to $\pounds 775$. This money will be given to the 2 charities that Gordon had chosen.

<u>Coat Road development has been approved by</u> <u>South Somerset District Council</u>

Some of you may have already heard that last Tuesday 17 December 2019 the Regulation Committee of South Somerset District Council approved the Barratt Homes planning application to build 120 homes on a site by Coat Road, Martock. The decision by District Councillors to approve the application was not unanimous however, but was passed by a majority only.

On the face of it this means that Barratt Homes can now proceed with the development. It is possible that the Regulation Committee's decision may be the subject of an appeal but we won't know whether this is going to be the case for at least a few weeks.

Martock Parish Council and Ash Parish Council have consistently opposed the Coat Road development. Both Parish Councils believe that the local infrastructure simply will not support the construction of this many homes on the Coat Road site.

We would like to thank everyone who got involved in this campaign. Whether you wrote to the District Council, attended public meetings or simply alerted friends or family many thanks and well done.

Although (so far) we've been unsuccessful, its good to see local people working so well together.
