NEWS FROM ASH PLAYGROUND

Installation of the new play equipment is currently scheduled to start on the 13th June. During installation, the play area will be locked, and some vehicles will need to be driven across the playing fields to get to the play area. The installation should take a matter of weeks. Please take extra care in and around the recreation grounds during the installation.

OVERGROWN VEGETATION

When hedges tree or shrub overhangs the highway, pedestrians can injure themselves from the impact with the vegetation and alternatively, pedestrians can be forced towards the carriageway, which can result in an increased risk of an accident. Responsibility for cutting back vegetation lies with the landowners or occupiers of their boundary fronting the highway. The Parish Council's responsibility is to report such matters to Somerset Highways.

Please can you check if any of your boundaries with the highway has offending growth and, if it has, make arrangements to remove any overgrown vegetation. Landowners must also remove any debris from the road surface to prevent nuisance and to stop it blocking surface water drainage systems. Thank you

22/34 Parish Council Matters – To adopt the Standing Orders

Cllr Davey asked for changes to Section 15. Proper Officer to allow the proper officer to be any member of the PC, not necessarily a staff member. The clerk advised that this was not necessary as any member of the PC is allowed to take the minutes should the clerk be unwell, after having had this clarified earlier in the year by SALC.

RESOLVED: It was unanimously agreed to adopt the Standing Orders.

POST MEETING NOTE – The Chair was unsatisfied with the explanation relating to the amendment to the Standing Orders and felt that the vote did not follow proper procedure.

This item will be on the next agenda for discussion and resolution.
