ASH PARISH COUNCIL PRECEPT 2023-2024

This year you probably won't study the itemisation of your annual Council Tax Bill, just simply scan to the bottom and look at just how much it has gone up by! The amount is likely to be significant, as the government has allowed local councils to put up their council tax by up to 5% without a referendum. Due to the soaring rates of inflation, many are doing just that.

Other items on the bill will be amounts for the Police, the Fire Authority, and the precept for the Parish. This is the amount that is given to Ash Parish to pay for maintenance and improvement of local services, which is administered by Ash Parish Council. All of these are likely to have gone up - except the amount which goes to Ash Parish Council!

We are all pretty tired of hearing about the cost of living crisis. When not droning on about errant members of the Royal Family, it seems the only thing that the media are interested in. But we can't avoid the fact that Inflation is currently running at over 10% and a simple visit to the supermarket will let anyone know that prices are rocketing. The result is that many parish councils are using the current situation as an excuse to put up their precept - some by 20% or even 30%.

Ash Parish Council have been discussing our budget for some time, but decided at their January meeting that for the second year running we would freeze our precept request, so by the end of next financial year, the amount charged for the Parish Precept will have remained the same for three years. Even though the actual amount of any potential rise might not have been significant for some, these three years will have been the toughest years financially that many of us will face, and so the Parish Council thought that it is an important point of principle when so many of our parishioners are struggling to make ends meet.

We are able to do this because of the financial responsibility of Ash Parish Council over a number of years, which has gradually put money aside for Parish projects and also because in the last year we have been very active in applying for a number of grants to subsidise these projects. The result is that we will still be able to make some significant improvements to the Parish, including the installation of bus shelters, improvements to the play area and the two car parks in the village and this year we will also finally have the cemetery extension consecrated - all without asking you for more money. Without these grants we would have had to raise the precept by over 16% to meet the same spending commitments.

We will also continue to maintain the parish, which includes keeping the green spaces, recreation ground, pavilion, car parks, cemetery and graveyard in good order.

Although a real terms a small gesture, Ash Parish Council hope that freezing the Parish precept will help your household finances slightly, and that it shows that we understand the issues our parishioners are facing.

COME AND LEARN CPR AND BE PREPARED TO SAVE A LIFE!

Training in CPR gives everyone the potential to help to save lives. When a person suffers a cardiac arrest or stops breathing, the key to giving them the best chance of survival is starting CPR as quickly as possible to prevent damaging effects from lack of blood flow to the brain, heart, lungs, and other organs.

Sudden Cardiac Arrest is witnessed by a bystander in approximately 37% of cases. That bystander could be you! Being trained in CPR provides the knowledge, confidence and skills to stay calm in a medical emergency and help a person in need.

Ash Parish Council are organising CPR training sessions in the village, all ages are welcome, first timers and those wanting to refresh their skills.

The Diocese of Bath & Wells recently advised all Church Treasurers that funding had been made available and would be awarded in the form of grants to assist with the cost-of-living crisis.

An application was made by Holy Trinity, Ash and the sum of £400 was awarded.

The application was based on working with the Parish Council, initially through the Coffee n Chat Coffee mornings, and extending to further hours based on demand to provide a Warm Hub within our community.

As there was no uptake on the offer of the Warm Hub, the PCC of Holy Trinity have decided to convert the £400 into eight grants of £50 as we feel there may be households within the Parish that would benefit for some financial assistance in these difficult times.

Should demand exceed the number of grants available, we may have to ask a few additional questions to establish who the money will best help.

Dear Lovely Neighbours

I'd like to introduce myself. I'm a hedgehog who lives in your street! Some of you may have seen me around. I'd love to raise my family and hang out with my friends happily in Ash as we love it here. But I need your help. Here are some suggestions.

- Leave out fresh water for us in a shallow bowl each night, especially in spring, summer and autumn when we are out of hibernation.
- Feed us meat and jelly-based cat food (not fish or gravy) and meat-based cat biscuits. Please avoid bread, milk, or mealworms as it upsets our tummies.
- We like to roam around, especially at night, but we avoid brightly lit areas. So please reduce light pollution by having your outdoor lights on a motion sensor or timer so they are not on all night and we can come out to feed.
- Make your garden part of a hedgehog highway for us. Talk to your neighbours and make a small hole at the bottom of fences etc. if it's 13 x 13cm we can get through.
- We like messy piles and dead leaves especially when it comes to looking for hibernation sites, so please make sure your garden isn't too tidy. It doesn't have to be all year but leaving the seedheads over winter and only tidying up once the weather gets warm in spring will help us.
- Make sure any garden netting you use is at least a foot above the ground. Otherwise, we can get in a right tangle!
- I love to hide in your long grass and brambles so please be careful when strimming. Always check first and if in doubt, do half a cut first with shears and check in between cuts.
- Please don't use slug pellets or other poisonous chemicals in your gardens as they make me very sick.
- Try not to dig too much, this helps build a healthy worm population for me to eat. Piles of wood, sticks and leaves are particularly good for woodlice and beetles, also, good for us to eat.
- An area of long grass; perhaps a patch that never gets mown, or an area that only gets mown once or twice per year, will help increase some butterfly and moth species, and we love to eat the caterpillars!
- Just to let you know we can go in and out of hibernation and may wake up intermittently for food and drink from time to time. Some of us won't be hibernating at all, especially if we were born late in the autumn.

So, do you actually have a hedgehog in your garden? Well; we have been spotted in all areas of Ash. If you check out <https://bighedgehogmap.org/> you can just put in your post code to the search area and you will see all the registered sightings in Ash and the surrounding area. We can roam a mile per night searching for food, so as long as you have a hole in your boundary 13x13cm we can get through and you could have a hedgehog visit. If you only have a stone or brick wall, don't worry, you can still have a hole, it just takes a bit more effort!

We hibernate in the winter, so this should be the wrong time of year to spot one of us. We come out of hibernation between March and May, depending on the weather. Male hedgehogs wake up first to prepare for mating season; it may still be quite cold and they will be very hungry and thirsty- we all lose 25% of our body weight while hibernating. So if you see me or one of my friends especially early in the year, it would help to put out some food for us, but don't put out food unless you know you definitely have a hedgehog or it will either be wasted or could attract rats, plus it needs to be located in a place where only hedgehogs can fit into or the local moggies will eat it too!

Not many people realise, but us hedgehogs – once so common in your gardens, on your streets, squashed on your roads that you hardly even noticed us – have (since 2020) we've been on the IUCN red list as 'vulnerable to extinction' in the UK.

Ash, with its a mosaic of green spaces, trees and shrubs, streets, wild verges and plentiful gardens, is ideal habitat for us hedgehogs, and could be even more so if people managed their gardens with your prickly friends in mind.

The Blue Campaign is Coming to Ash

What is The Blue Campaign - The Story

The Blue campaign was founded in 2014 by wildlife film maker Fergus Beeley, in response to dramatic biodiversity and biomass declines in the UK. Easy and effective, the only requirement is to allow a patch of land to grow and see what plants and creatures return.

As with all the best ideas it's amazingly simple and has been taken up across the country. People have been rewilding private gardens, allotments and business yards. An increasing number of councils are also working with the Blue Campaign to rewild council land and roadside verges. To mitigate any concerns regarding neglect of the area, an initiative called the Blue Campaign begun which encourages people to erect a blue heart on a wooden post to alert members of the public to the project.

Rewilding Ash

One simple but incredibly effective action that Ash Parish Council can take is to turn the roadside verges outside the Village car park into a native wildflower meadow. This requires far less maintenance than traditional mowing schedules, saving the council money, reducing our carbon footprint and significantly increasing local wildlife density and diversity. At its meeting on 9th January 2023 the Parish Council agreed to allow the grass to remain uncut around the Village car park verges to allow any wildflowers to flourish, before considering additional sowings for future rewilding. It was agreed that the edges would remain tended to indicate the purposeful nature of the uncut area.

Starting this season these verges will have just one annual cut-and-collect followed by little to no maintenance. This will allow native plants to quickly begin to re-establish themselves, bringing with them a wonderful variety of invertebrates, birds, amphibians, reptiles and mammals.
