COUNCILLOR VACANCY ON ASH PARISH COUNCIL TO BE FILLED BY CO-OPTION

Ever thought about becoming a Councillor? If you did you could:

To qualify, you need to be 18 or over & meet at least one of the following four qualifications:

- You are, and will continue to be, registered as a local government elector for the parish in which you wish to stand from the day of your nomination onwards.
- You have occupied as owner or tenant any land or other premises in the parish area during the whole of the 12 months before the day of your nomination and the day of election.
- Your main or only place of work during the 12 months prior to the day of your nomination and the day of election has been in the parish area.
- You have lived in the parish area or within three miles of it during the whole of the 12 months before the day of your nomination and the day of election.

Knife Angel, Somerset

The Knife Angel visits Taunton, Somerset from 3rd to 30th April

A sculpture which aims to raise awareness of the negative effects of violence and aggression will be in Somerset next month as part of a nationwide tour.

The Knife Angel stands at 27 ft tall, weighs 3.5 tonnes, and was designed by artist, Alfie Bradley at the British Ironwork Centre using 100,000 knives and blades retrieved from amnesty bins from across all 43 UK police forces.

Somerset Council and Taunton Town Council are supporting and encouraging a 30-day campaign of anti-conflict awareness raising with schools, community groups and local businesses.

The Knife Angel will be placed outside the Market House in Taunton from 03 - 30 April.

Somerset remains a safe place to live with relatively low levels of knife crime, we fully support the aims of the sculpture and strongly condemn all forms of violence. We hope the presence of the Knife Angel in Somerset during April will help raise awareness of an important national issue.

What does this mean?

- This will enable our team to complete any outstanding requests in the current askmyGP system alongside dealing with on the day demand.
- If you wish to submit a new request between the 4th and 23rd April, please phone the surgery and talk to one of our reception team.
- The surgery will be **focusing on acute* requests during this period** (please note nursing appointments remain unchanged).
- We expect our **phone lines to be busier than usual** and ask that patients try to space their calls across the day where possible to reduce the length of time you have to wait.
- This transition period is crucial in ensuring that we are able to focus on getting the best out of our new system from the 24th April for both our staff and patients.
- · We appreciate your patience and understanding during the interim period.

Although there will be a short period where no online system is available whilst we transition, we still strongly recommend online access as the best way to submit requests when Anima is live.

- Once askmyGP is closed on Wednesday 3rd April, we will share sign up links to Anima via our website and text message. This will include a guide helping you to get signed up.

CONSULTATION OF ASH PARISHIONERS

Designation of Ash Millennium Wood as a "Local Nature Reserve"

Ash Parish Council proposes to declare Ash Millennium Wood as a "Local Nature Reserve" (LNR). We would like to hear the views of people who live in the Parish on the proposal.

Local Nature Reserves are areas of locally important natural heritage intended to give better opportunities to learn about and enjoy nature close to where people live. Local authorities (including Parish Councils) select and declare LNRs using powers under national legislation. These sites then receive protection through local planning policies that aim to resist development which would adversely affect them. Once declared Local Authorities are responsible for making arrangements for the appropriate management of the site. Further details can be found at:

Declaration of a LNR supports the PC's commitment to help nature recovery (as outlined in its Biodiversity Policy) through protecting and enhancing the diversity and quality of the wildlife which is already present. It will reflect the effort invested by the Millennium Wood Management Group and local volunteers into management of the site for nature, recreation and education. The management plan for the site will also encourage greater involvement and participation by volunteers and users in learning about and managing the site's special habitats and species.
