ASH PARISH COUNCIL UPDATE

At the Ash Annual Parish Council Meeting on 13th May, Cllr Davey was re-elected as Chair and Cllr Halfhide as Vice Chair.

We also welcomed Cllr Alan Britten, who was co-opted onto the Parish Council at the same meeting. We wish him all the best in his endeavours as a council member.

CHAIR'S REPORT 2024

You might be surprised to hear it, but being on Ash Parish Council is far from glamorous. Most of the job involves organising, or in many cases just doing, the minutiae of Parish life. This might be arranging for the consecration of the new cemetery; sorting new disabled access paths for the village car park and the recreation ground along with proper access gates; providing, installing and maintaining defibrillators; planting trees and hedgerows and making sure that Parish land is well maintained.

To do all of this, we set and administer the Parish Precept - the share of your Council Tax that pays for the running of the Parish. For the past three years we have managed to keep this precept at the same level and not increased it at all. When the cost of living crisis was at its peak, we wanted to do as much as possible to help parishioners to make ends meet. Now that things are easing, we have had to face reality and increase the precept for the first time in three years.

During this three year period, estimates for the accumulative rate of inflation using ONS data is around 27%. Quite simply, everything that we do on your behalf is costing more than it did three years ago. Having the rate of inflation drop to something reasonable doesn't mean that prices have gone down. It means that prices are going up more slowly, and unfortunately we have had to reflect that by raising our Parish Precept by 14% - a little over half of what inflation has been doing during the same period.

The situation is not helped by the fact that the combination of government cuts and previous financial incompetence has led to the newly and expensively dreamt up Somerset Council trying to shirk off many of their responsibilities on to Parish Councils. They have presented us with a number of these 'opportunities' under the justification that we can charge you whatever we like and get away with it, whereas they are limited by statute. What they don't acknowledge is that through your council tax, you have already paid them to do the things that they are suggesting that we charge you again for.

Whilst government funding decisions have undoubtedly contributed to the financial position, there is a negative financial legacy from previous iterations of the various non-unified Somerset councils have also played a part - such as apparently spending £289 million on a property portfolio that is now worth only £220 million. We are also yet to see any of the promised financial benefits from the expensive creation of the unified Somerset authority.

Luckily, Somerset don't do a great deal directly for this Parish, and we are actively resisting all attempts to take on extra things at your expense, although we do have to make some form of contingency. For example, if Somerset stop paying for dog poo bins to be emptied then we will either have to step in, or we will literally and metaphorically be in excrement.

What we can promise you though is that Ash Parish Council will always do our best to spend your money as wisely as possible, whilst trying to make continued improvements to facilities in the Parish.

DON'T LET YOUR HEDGE BECOME A HAZARD

It is that time of year when everything in the garden is growing significantly but unfortunately this has given rise to a number of complaints that overgrown gardens are obstructing pavements or obscuring sight lines for drivers. In particular this can be a problem along stretches of Main Street where the pavement is particularly narrow.

When hedges, trees or shrubs overhang the highway, pedestrians can injure themselves from the impact with the vegetation and alternatively, pedestrians can be forced towards the carriageway, which can result in an increased risk of an accident. Responsibility for cutting back vegetation lies with the landowners or occupiers of their boundary fronting the highway and pavements. Landowners must also remove any debris from the road surface to prevent nuisance and to stop it blocking surface water drainage systems.

Please can you check if any of your boundaries with the highway or pavements has offending growth and, if it has, please make arrangements to remove any overgrown vegetation.

CONSULTATION ON DESIGNATION OF ASH MILLENNIUM WOOD AS A LOCAL NATURE RESERVE (LNR)

The consultation was carried out between 8th April and 10th May 2024. Community Groups and interested parties were consulted as stakeholders via email. Owners of land adjacent to the site were consulted by letter. All Parishioners were invited to comment and were informed via the Parish newsletter and Ash email alerts.

Stakeholders consultation

Five stakeholders provided a response (Ash Primary School, 1st Fosseway Scouts, Ash Primary School, ecologist, Somerset Environmental Records Centre). All were very much in support of designation. A typical response was (from the Headteacher at the adjacent Primary School):

"We would wholeheartedly support the application for the Millennium Wood to become an LNR. This would not only protect the space for the use of the community, including the children and families of Ash Primary School and Nursery, but it would also support the development of the project over time to become an even greater haven for nature and wildlife. All our pupils and staff benefit from the woodland, and it provides an important educational and wellbeing resource."

One response was received from landowners, in support of the proposal.

Parishioners consultation

There was a clear majority of responses supporting the designation of the wood as a Local Nature Reserve. Of 61 responses there were 47 in support (77%) and 14 who were opposed (23%).

There were additional questions asked:

- 1. Have you visited the wood: all answered "yes";
- 2. **What do you like best**: most common responses related to its peacefulness and the chance to experience the natural environment. There were also some who enjoyed it for walking, especially with a dog.
- 3. What changes would you like: by far the most common response was to continue the current management regime. There were also many calling for greater control of dogs. Some also asked for more seating.
- 4. **Any further comments**: most common responses identified the site as an important community asset and valuable for people and wildlife and thanked the volunteers for looking after it.

These results will help inform the forthcoming management plan for the wood. It should be noted that the proposed LNR designation will not change the current ownership, access, management arrangements or the aim to make it a great place for wildlife and people.
