Natural England has asked that we consider identifying other adjacent areas for nature conservation and that we look for common themes identified by those objecting.

- Adjacent areas: Ash Biodiversity Working Group will explore options and report to the PC.
- Objections: The biggest points raised in objection are changes in ownership/management arrangements and new restrictions on access. In both these there is a misunderstanding on the part of objectors because no such changes are proposed as a result of designation.

The process is now with Somerset Council to take forward.

This led to a discussion regarding dogs in the play area, and it was confirmed that no dogs were permitted in the play area. Several people mentioned speeding and Cllr A Groves suggested they might like to help with the local speed watch scheme which would identify speeding vehicles. Cllr A Groves said she had received a complaint regarding the state of the pathway from Durnfield to Ash. The pathway is very overgrown. Cllr Groves has acknowledged the complaint and has sent a report to Somerset Council as this path gives a safe route for walkers and cyclists wishing to avoid the A303. She will keep us informed on this matter; Cllr England offered to go and look at the situation and report back.
