1 Somerset News

1.1 - Support for Somerset households with food and energy bills this winter

Somerset families and residents who are struggling to pay the bills this winter could be eligible for support with the cost of food, energy, water, and other essentials over the coming months.

Somerset Council will be distributing £3.8m to those in need between October 2024 and March 2025 as part of the Government's Household Support Fund. The funding will be spent as follows:

To provide food and fuel vouchers and essential items directly to those in need. These applications can be made by Social Workers, Health Visitors, Village Agents, Social Prescribing Link Workers and Parent Family Support Advisers on a household's behalf, which will ensure that those who are unable to apply themselves can still benefit.

To support Age UK Somerset, Citizens Advice Somerset, Community Council for Somerset and Somerset Activity & Sports Partnership to deliver their vital support for the county's most vulnerable families and residents.

To be used during the school holidays to provide food vouchers worth £10 a week to children eligible for Free School Meals, supporting at least 15,000 children this winter.

To support Somerset Community Foundation's Help Through Winter Fund, including support for four initiatives:

- 1. Support for hard-to-reach rural communities via local warm hubs, using local community spaces to support families and residents to access help such as help with training or employment opportunities and food banks, larders and pantries.
- 2. Cost of living grants for frontline organisations who are experiencing increased demand during the winter period to ensure they can continue to supply services for the community such as free wellbeing activities or free-to-use community transport.
- 3. Grants for vulnerable families and older people to help cover heating costs and activities to reduce loneliness and isolation.
- 4. Supporting charities which help homeless people, including helping fund essential furniture such as white goods. Deputy Leader of the Council and Lead Member for Finance, Procurement and Performance, Councillor Liz Leyshon said:

"We know that many Somerset households will continue to be affected by the cost-of-living crisis this winter, so this additional funding will make a real difference in the lives of our most vulnerable residents."

"We have ensured that the funding is allocated across community groups and through Somerset Community Foundation with a view to supporting people of all ages and abilities in our communities. Our partnership with local community groups is critical to ensuring that the help reaches those who need it most."

1.2 - Somerset Council invites public opinion on the future of Somerset's pharmaceutical services

Somerset Council is calling on residents to help shape the future of pharmaceutical services in the county.

The council is conducting a Pharmaceutical Needs Assessment (PNA) consultation for the public to share their thoughts and contribute to the Pharmaceutical Needs Assessment statutory report produced by the Somerset Health and Wellbeing Board.

The PNA is a comprehensive assessment of the current and future pharmaceutical needs of the local population and is used to review local community pharmaceutical services and evaluate whether they adequately meet the county's needs.

NHS commissioners use the results of the PNA to work out if any changes might be needed in local pharmacy services. Despite the name, the PNA does not review the quality of pharmaceutical provision, it helps to inform decisions.

We encourage the people of Somerset to share their thoughts and experiences by completing the online survey before 1 January 2025.

1.3 - New Changing Places Facility opens at the Quedam Shopping Centre, Yeovil

Somerset Council and The Quedam Shopping Centre are proud to announce the opening of a new Changing Places facility.

Located within the Quedam Shopping Centre in Yeovil, the new Changing Places facility is designed to meet the needs of individuals with profound and multiple learning disabilities, as well as other disabilities that severely limit mobility. It provides a safe, clean, and fully equipped space, ensuring dignity and comfort for all users.

This state-of-the-art facility is the result of a successful partnership between the Quedam Shopping Centre and Somerset Council, and has been funded through the central government's Changing Places Toilets Fund.

Key Features of the Changing Places Facility:

Height-adjustable adult-sized changing bench - Ceiling hoist system - Ample space for carers - Centrally located toilet with room on both sides for assistants - Privacy screen

Councillor Federica Smith Roberts, Lead Member for Communities, Housing Revenue Account, Culture and, Equalities and Diversity said:

"The new Quedam Changing Places facility marks a significant step forward in making Yeovil a more inclusive and accessible town for everyone. We are grateful for the support from the central government's Changing Places Toilets Fund and look forward to seeing the positive impact this facility will have on visitors to the shopping centre."

James Tovey, Manager of the Quedam added:

"We are thrilled to see the completion of the Changing Places facility at the Quedam Shopping Centre. This project underscores our commitment to inclusivity and providing essential amenities for all members of our community."

A ribbon-cutting ceremony was held today, Monday 11 November, when it was officially opened by Councillor Federica Smith Roberts and Quedam Manager James Tovey who were accompanied by Adam Dance MP and Dave Crisfield, former Community and Equalities Officer at Somerset Council.

1.4 - Consultation on Local Validation Checklist for Somerset

Views are being sought on a new Local Validation Checklist covering the Somerset Council area.

Local Validation Checklists (LVCs) help inform applicants and agents about the type of documents and level of information required to be submitted in order for the Council to validate a planning application and/or other consents.

Each of the former councils which make up Somerset Council had an adopted LVC reflecting the Local Plans for their area.

Local Planning Authorities (LPAs) are required to maintain an up to date LVC and review it every two years.

This will be the first LVC for the Somerset Council area and where necessary it includes specific requirements from the former LPA's adopted Local Plans while a new Local Plan for Somerset is being prepared.

Cllr Mike Rigby, Lead Member for Economic Development, Planning and Assets, said: "We are committed to providing a professional and efficient service for all potential applicants and agents.

"The LVC will help them to prepare their submissions and ensure they can be validated and determined as swiftly as possible. I would urge all interested parties and members of the public to share their views with us."

The Council will consider all comments on the draft LVC which may be amended to take account of comments, observations and updates that assist with the content and clarity of the document.

The proposed final version will be considered before a decision is taken to adopt the new LVC in 2025.

1.5 - Improved Council payment systems introduced

An improved 24-hour payment system is on the way for anyone wishing to pay for key Somerset Council services online or over the phone. From 5 December, residents will be able to pay for the following services over the phone at any time of the day, seven days a week using the new automated system: Council Tax - Business rates - Housing and garage rents - Parking fines

Once the new system is in place, there will be no need to wait in a queue and customers will use their phone's keypad to enter their payment details. The system will also allow people to pay invoices, for example paying for a Somerset Lifeline subscription. Customers will be transferred to the new system, known as Touch Tone, when they call from Thursday 5 December. Other ways to pay – including Direct Debits, standing orders, bank transfers, or by visiting a Pay Point or Post Office – will continue as before. Alongside the updates to the phone payment line, Somerset Council's online payment system will also be upgraded. Payments for other types of services will need to be completed online. To prepare for the switchover, Somerset Council's current phone and online payment systems will be unavailable from Tuesday 26 November to Wednesday 4 December.

During this time customers will still be able to pay in the following ways: Bus gates and parking penalties by bank transfer or Invoices by bank transfer

Council Tax, housing and garage rents, Business Rates at the Post Office or a Pay Point. Setting up a Direct Debit is recommended to make future payment easy. Customers will need to use a valid reference number to make the payment.

Councillor Federica Smith-Roberts, Lead Member for Communities, Housing and Culture, said:

"Our customer service team take more than 30,000 payments a year and it's important that we have a service that meets the needs of residents and the council. The new improved payment system means people will be able to make some of the most important and frequent payments, 24/7 throughout the year rather than having to wait on the phone for a member of staff. Moving to one modern payment system means that customers can pay at a time convenient to them."

The quickest and easiest way to pay for most council services is online. Residents can pay by visiting www.somerset.gov.uk. When the payment system re-opens customers will be transferred to the new platform.

1.1 - Coming soon: Local Plan Call for Sites

Somerset Council will be launching a Call for Sites in the new year as it prepares to develop its first Local Plan. The Call for Sites is a six-week period where landowners, developers, and site promoters are invited to submit land they want to be considered for future development. Submissions can be for various uses including housing, economic development, gypsy and traveller pitches and plots, and renewable energy installations.

The Call for Sites is one of many ways the Council will be gathering information for the Somerset Local Plan. It is not encouraging submissions in particular locations. Submitting a site is not a planning application and does not grant planning permission or any other status.

The Local Plan guides decisions on future development proposals based on the needs and opportunities of the area, identifying where development should take place and areas where development should be restricted. Understanding potential supply of development sites is a key early step in this process. The new Somerset Local Plan will generally supersede all existing former district council Local Plans, which will remain part of the Development Plan until they are officially replaced.

1.2- Yeovil Refresh: Triangle set to re-open early in the New Year

One of the most exciting areas in the rejuvenation of Yeovil town centre is well underway to being fully unveiled to the public in early January 2025.

The area known as 'The Triangle' at the eastern end of the town has been the focus of complex and extensive redevelopment and upgrade, in a transformation designed to boost much needed investment in Yeovil's economy.

The creation of the state-of-the-art amphitheatre style entertainment space came about after local people and businesses shared ideas about what they would like to see in their town, for their community.

The space features seating for about 100, around an open space that incorporates a water feature which will be commissioned in the spring. The thoughtfully designed open space in the heart of town will be a place for people to gather or simply take time out during the day. A raised stage with large screen for live performances and screened events, as well as art installations commissioned and co-created with local community groups during the Covid pandemic, will create what is hoped will become a popular focal point for the community.

Works to complete the new entertainment space will continue and an official opening of the Triangle will take place early in the new year. Further details will follow.

1.3 - Leaders welcome Devolution White Paper

_The Leaders of Dorset, Somerset and Wiltshire Councils are optimistic that they can work with Government to progress proposals for the Heart of Wessex Mayoral Strategic Authority following the publication of the Devolution White Paper. In a joint statement, the leaders of Dorset, Somerset and Wiltshire Councils, Cllr Nick Ireland, Cllr Bill Revans, and Cllr Richard Clewer, said:

"We welcome the publication of the Devolution White Paper as a significant step forward in our journey towards achieving devolution for the Heart of Wessex region. This milestone reflects the Government's commitment to empowering local communities and enabling regions like ours to collaborate on our shared vision. "Government has made it clear that if strategic authorities are going to maximise the funding opportunities available devolution deals will require a mayor and minister will be able to impose mayors and geographies on local councils. The establishment of the Heart of Wessex Mayoral Strategic Authority represents a fantastic opportunity to have a champion for the Wessex region who will be able to deliver

meaningful change for our residents and advocate for our interests in Westminster. This will also offer the likely opportunity for increased funding and investment to our council regions. We want to make the Heart of Wessex a thriving region whose unique interests are heard and understood by central government.

"This proposal ensures clear, accountable leadership to drive economic growth, improve public services, and invest in vital infrastructure across the region. This model will see additional powers handed down from central government and redefine local decision-making, unlocking significant opportunities for our residents and businesses. "The Heart of Wessex encompasses real strengths in sectors such as defence, digital, life sciences, advanced manufacturing and clean energy, and devolution offers the opportunity to secure additional funding for the critical infrastructure needed with the ability to attract additional private sector investment.

"We have made clear our strong desire to be considered in the first tranche of devolution agreements. We look forward to working with Government to discuss how quickly we can progress devolution to lead change in local government." If the devolution proposal is approved, Dorset, Somerset and Wiltshire councils will continue to exist and are expected to have the same responsibilities as they do now. Litter Bin and Dog Waste Bin charges 25/26

I am writing about the proposed changes to the emptying of litter and dog bins on city, town or parish council owned land for the financial year 25/26.

Historically there has been **no charge** for collections in the former **Mendip and South Somerset Districts, on non-council owned land.**

However, this is inconsistent with the former Somerset West and Taunton and Sedgemoor Districts, where collections are chargeable on non-council owned land.

The Council's intention is to begin charging for litter and dog bin emptying on non-council owned land from April 1st, 2025, in those areas where there has not previously been a charge.

A consistent, countywide cost per empty is yet to be decided, but as a guide, the charge in the former Somerset West and Taunton is £7.82 +VAT a collection.

To do this, we need to verify that our data is correct, and we are clear which bins are Somerset Council-owned and which are owned by you, in the parishes.

A combined list is provided (attached)

For clarity, we would like you to note that attached is a **combined list of both Somerset Council owned and city, town or parish owned bins** which is taken from our collection schedule.

We are asking each city, town and parish council to confirm:

• That the total combined number of bins is correct.

- The type (dog or litter) and location of the bins (What3Words would be helpful, but a road name or similar is fine)
- Which bins are Somerset Council-owned, and which bins are city, town or parish owned.

Please email your responses to: somerset.gov.uk

We appreciate that these records may not be 100% accurate, but validating our data is an important first step and allows us to set our emptying costs accurately.

Local knowledge is very much appreciated in helping with this.

Next steps

Once we have verified this information, we will be able to offer the following three options to you for the bins that are on city, town or parish land:

- A cost for Somerset Council to empty the bins. This will be per bin per collection.
- Devolve the bin emptying to the city, town or parish council. This will allow the city, town or parish council to arrange for their own disposal of the waste.
- Remove the bin(s).

There will be no charge passed on to city, town or parish councils for emptying Somerset Council-owned bins.

The service will continue as normal, during 25/26.

We ask that this information is returned to us by Friday 9th August so that there is time for Somerset Council to respond and for councils to make decisions ahead of setting budgets for 25/26.

To further support decision making, we would also like to offer a bin consultation to city, town and parishes (subject to available resource). This is an extension of the scheme offered in the former South Somerset District Council area, where officers advise on different types of bins that are available and how this can reduce the number of bins and collections required.

If this is something your city, town or parish council would like to request, please can you also let us know in your email response.

We have a team working on this so if you have any queries, I can arrange for an officer to make contact and talk any problems through.

We also recognise that some city, town or parish councils have large numbers of bins, and it may not be as easy to provide the information we have asked for. If this is the case, then again please let me know and I will arrange for an officer to call.

Hi,

I write in regard to the litter and bin charges for your parish areas that were communicated in the attached letter back in the summer.

Thank you to everyone for their responses and input on locations of bins. It is very much appreciated.

I am pleased to say that we have completed the task of bringing together the dog and litter bin process across the county. The process is the same now for all parishes. I am also pleased to say that we have been able to set the provisional charge per bin, per collection at £6.50 + VAT, which is lower than the suggested figure in the letter.

Therefore, a single bin, emptied once a week, will be charged at £338 +VAT a year.

To reiterate, this is a charge for bins on non-council owned land only. There is no charge for the collection of bins on Somerset Council land. This includes highways bins.

I do need to caveat that the charge is provisional until our fees and charges are formally approved by Full Council in January.

Officers will be in touch in the new year to confirm whether this is a service you wish to continue with, and arrangements for invoicing etc if it is.

Revised Expression of Interest in devolution by Dorset, Somerset, and Wiltshire Councils

Dorset, Somerset, and Wiltshire Councils have revised their Expression of Interest in devolution, committing to a Mayoral Combined Authority for the Heart of Wessex region.

In a joint statement, the leaders of Dorset, Somerset and Wiltshire Councils, Cllr Nick Ireland, Cllr Bill Revans, and Cllr Richard Clewer, said:

"We have submitted a revised Expression of Interest to central government for the Heart of Wessex devolution deal. This submission reflects our shared vision for unlocking significant opportunities for our communities through local empowerment and collaboration.

"This is not a merger of the three councils, all three will remain separate local authorities. Devolution is the handing down of powers and decision making from central government to new 'local partnership' areas. The make-up of the individual councils who may work together will not change.

"Whilst our preference would be for not having a mayor, Government has made it clear that all devolution deals will end up with Mayoral Combined Authorities. Ultimately, this model will help secure better funding deals for our region; therefore, our revised proposal aligns with this approach, and we have set out our commitment and intent for a directly elected mayoral governance system. This proposal ensures clear, accountable leadership to drive economic growth, improve public services, and invest in vital infrastructure across the region, working closely with the leaders of the constituent councils.

"The Heart of Wessex encompasses a region of significant potential, and we feel that devolution at scale can support our ambitions to ensure our local economy thrives and is supported by a skilled, secure and well-paid workforce. Mayoral devolution also offers the opportunity to develop a long-term investment plan for the critical infrastructure our counties need with the ability to bring in additional private sector investment.

"We have made clear our strong desire to be considered in the first tranche of devolution deals, recognising the commitment of our councils to lead change in local government and move forward as swiftly as possible.

"With a population of approximately 1.5 million, we believe the Heart of Wessex presents a realistic and ambitious offer which can redefine local decision-making and partnership across the patch, offering the Government an opportunity to showcase what devolution can offer to the region and to the wider UK. The Heart of Wessex has real strengths in sectors such as defence, digital, life sciences and clean energy, and devolution will help ensure the success of these sectors in kickstarting economic growth, making Britain a clean energy superpower and breaking down barriers to opportunity.

"Once an outline of proposals has been agreed with central government, we will need to share these with residents and will be seeking feedback on the detail of any arrangements as part of a formal consultation."

If the devolution proposal is approved, Dorset, Somerset and Wiltshire councils will continue to exist and have the same responsibilities as they do now. The offer to BCP Council and Swindon Borough Council to join the Heart of Wessex partnership remains open.

DEVOLUTION FREQUENTLY ASKED QUESTIONS

What is devolution?

Devolution is the handing down of powers and decision making from central government to new regional areas.

Why has the government asked Somerset Council to submit a proposal for devolution?

In July 2024 the Deputy Prime Minister wrote to all local authorities without a devolution deal asking them to submit proposals via an 'expression of interest' for a devolution deal. This letter can be found here: Letter from the Deputy Prime Minister to local leaders: the next steps to devolution - GOV.UK (www.gov.uk)

This was accompanied by a stated aim that the government "aims to widen and deepen devolution across the country, by pushing power out of Whitehall and into the hands of local people to drive regional growth".

What has Somerset Council asked for in its expression of interest to government?

Following extensive discussions with neighbouring authorities Somerset Council has submitted an expression of interest in September proposing it explores a devolution geography called the 'Heart of Wessex' with Wiltshire and Dorset Councils. Recently, Dorset, Somerset and Wiltshire Councils jointly revised this expression of interest to make clear they would support a Heart of Wessex geography with an elected mayor.

Why was the expression of interest revised to support an elected mayor?

Government has made it clear that they are committed to devolution deals that include mayors. Therefore, the revised proposal aligns with this approach. This model ensures clear, accountable leadership to drive economic growth, improve public services, and invest in vital infrastructure across the region, working closely with the leaders of the constituent councils.

Devolution at scale can support our ambitions to ensure our local economy thrives and is supported by a skilled, secure and well-paid workforce. Mayoral devolution also offers the opportunity to develop a long-term investment plan for the critical infrastructure our counties need with the ability to bring in additional private sector investment.

Should mayoral devolution be agreed, residents would have the opportunity to vote for a mayor.

What about BCP and Swindon?

Discussions to date have also included BCP Council and Swindon Borough Council. Dorset, Somerset, and Wiltshire councils remain open to the possibility of working with BCP and Swindon across the Wessex region.

When will we hear back from the government regarding the proposal?

There is no formal timeframe for a response from government. However, we are actively engaged in discussions with central government to understand any initial feedback regarding the Heart of Wessex proposal.

Does this mean Somerset Council is committed to the Heart of Wessex geography with no ability to change it?

No. The Leaders of Dorset, Somerset and Wiltshire Councils have been clear that further guidance is now needed from the government alongside the opportunity to review the draft English Devolution Bill when it is published.

Will Somerset Council be merging with Wiltshire and Dorset if the Heart of Wessex devolution proposal is agreed?

No. There are no plans to share any services between the three councils. The aim of devolution is to unlock additional funding streams from central government and that we would work collaboratively with Dorset and Wiltshire on new initiatives.

If the devolution proposal is approved by government, local councils in Wiltshire, Dorset and Somerset will continue to exist and have the same responsibilities as they do now. The current legal, tax-raising and public service responsibilities of individual councils will remain with those councils. Any formal proposals will be subject to consultation.

What will the process of consultation look like?

We expect the process of consultation under this government to be set out in the draft English Devolution Bill so further detail about this is not available at this stage.

How would the Heart of Wessex proposal work in practice? What type of authority would actually be created if devolution is agreed for Somerset?

We expect the governance framework to be based on the combined authority structures provided for in existing legislation. Combined authorities are a legal structure that may be set up by local authorities in England. They can be set up with or without a directly elected mayor. Under the previous government, combined authorities could be set up by two or more local authorities and would take on statutory functions transferred to them by an Order made by the relevant Secretary of State, plus any functions that the constituent authorities agree to share.

The types of functions new combined authorities will be responsible for under this Labour government will likely be those proposed for inclusion in the English Devolution Bill e.g. strategic planning, local transport networks, skills, and employment support.

When will the draft English Devolution Bill be published and come into force?

There is no formal timetable for publication of the draft English Devolution Bill or its introduction to Parliament. However, we expect publication of the draft Bill before the end of 2024.
